Total estate comprises 23,000 acres.

Used as USAF HQ 1939-45.

Contents of Hall sold by Christies realising approximately £5.4 million 1984.

Collection of Suffolk manuscripts bought for the county 1987.

War memorial erected on Newmarket–Thetford road 1921 (Designed by Clyde Young.

First tank trials held on estate prior to use on the Somme 1916.

Estate once renowned for its shooting parties, now best known for its forestry.
